### RESOLUTION OF THE GOVERNING BODY OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA

RESOLUTION NO: 12-TM-31

**BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA, THAT:**

**WHEREAS**, this organization is a recognized Indian organization as defined under the Indian Reorganization Act of 1934, as amended, and exercises rights of home rule and is responsible for the promotion of the economic, health and welfare of its members; and

**WHEREAS**, the Te-Moak Tribe is the parent council for the communities of Elko, Battle Mountain, South Fork and Wells; and

**WHEREAS**, the Constitution of the Te-Moak Tribe of Western Shoshone Indians of Nevada establishes Regular Band Council Elections; and

**WHEREAS**, the Election Procedures Ordinance, 03-ORD-TM-01, provides that the Tribal Council adopt, by resolution, a specific date for regular Band Council and Tribal Council Elections, and

**WHEREAS**, the Te-Moak Tribal Council adopted Resolution 12-TM-17 setting the Regular Band Council Election for October 9, 2012, and

**THEREFORE BE IT RESOLVED**, in accordance to the Constitution of the Te-Moak Tribe and Election Procedure Ordinance, the Tribal Council for the Te-Moak Tribe hereby sets **October 29, 2012** as the day for the regular, tribal-wide Tribal Council Elections


