RESOLUTION OF THE GOVERNING BODY OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA

RESOLUTION NO: 12-TM-01

BE IT RESOLVED BY THE TE-MOAK TRIBAL COUNCIL OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA, THAT:

WHEREAS, this organization is a recognized Indian Organization as defined under the Indian Reorganization Act of 1934; as amended, and exercises rights of home rule and is responsible for the promotion of the economic and social welfare and well being of its members; and

WHEREAS, the Te-Moak Tribe is composed of four (4) constituent Bands, Elko Indian Colony, Battle Mountain Indian Colony, South Fork Indian Reservation and Wells Indian Colony; and

WHEREAS, the Te-Moak Tribal Membership consists of 2,203 members; and

WHEREAS, Public Law 108-270. "*The Western Shoshone Claims Distribution Act*," was passed by and signed into Law on July 7, 2004; and

WHEREAS, Public Law 108-270 is to provide for the use and distribution of funds awarded to the "*Western Shoshone Identifiable Group*" under the Indian Claims Commission, Docket Number 326-K, 326-A-1 and 326-A-3; and

WHEREAS, regulations governing the compilation of rolls of Indians by the Secretary of the Interior pursuant to statutory authority set out in the 25 CFR 61.9 provide that the burden of proof rests upon the applicant to establish eligibility to share in a per capita payment; and


WHEREAS, on March 4, 2010 the Western Regional Office met with the Western Shoshone Tribal Leaders and an established cut-off date was approved and published in the Federal Register for August 2, 2010,

THEREFORE BE IT RESOLVED, the Te-Moak Tribe of Western Shoshone Indians of Nevada is hereby recommending that due to the August 2, 2010 cut-off date and the March 2011 partial payment distribution the Western Regional Office should be more than prepared to finalize the Western Shoshone Claims Distribution.

AND, THEREFORE BE IT FURTHER RESOLVED, the Te-Moak Tribe of Western Shoshone Indians of Nevada by approval of this resolution is informing the Bureau of Indian Affairs the June 5, 2012 date shall be recognized as the final date for distribution of the Western Shoshone Claims Distribution.
